- b) Pay check stubs or receipts for past 4 pay periods for all household members employed
- c) Checking and savings account statements
- d) Statements for any investment accounts including retirement accounts, stocks, bonds, annuities, securities, pension plans, CD's and IRA's
- e) Documentation of any other forms of income from private individuals or programs
- f) Rental lease or mortgage documents
- g) Monthly bills including utilities, insurances, auto payments, child support payments, etc

If need for assistance is related to a medical concern, documentation regarding issue is requested.

Initial interview usually lasts 3 hours to complete. Person/Family must complete and sign a 4 page application giving detailed information on residence, employment, income, assets, a chart of monthly expenses, a review of current human service needs and any additional pertinent information.

Information is then reviewed, documentation is copied for files, reviewed to insure accuracy.

Social Worker reviews service needs and addresses their needs either with direct assistance or referrals to other agencies.

If assistance to be provided is approved, payment is made directly to the provider either by check or credit card.

Social Worker and Executive Director together review all documentation.

The Board of Directors have given the Social Worker and Executive Director authority to approve and make payments to providers up to \$1,500/per incident twice. Third requests for assistance or amounts over \$1,500 must have majority approval of the Board of Directors.

Social Worker and Executive Director report monthly to the Board of Directors on all requests.
